- roadways/parking lot to be hard surfaced;
- all water connections to comply with the Cross Connection and Backflow Prevention policy;
- pressure tests to be conducted on existing water lines to confirm integrity & service continuity between residences and main line;
- confirmation of sufficient sewer capacity;
- infrastructure improvements and testing to be certified by a Professional Engineer by Certificate of Acceptance;
- all structures within condominium must conform to the Municipal Zoning By-law.
